

## Successful Completion of Iroquois' 08/09 Expansion Project

On November 1, 2009, Iroquois placed a second compressor unit in service at its Brookfield Compressor Station located in Brookfield, Connecticut, concluding the final phase of its 08/09 Expansion Project.

Designed to meet the energy needs of KeySpan/National Grid, the 08/09 Expansion Project will deliver an additional 200,000 million cubic feet per day of natural gas from Iroquois' interconnect with the Algonquin Gas Transmission System in Brookfield, CT to National Grid's local distribution system at South Commack, Long Island.

Construction activities for the final phase of the project began in March 2009 with site clearing and grading, while the actual construction of the compressor facility began in July. The addition to the

Brookfield Compressor Station included the installation of a 10,300 hp Solar Taurus 70 turbine compressor as well as a cooling facility.

Other facilities constructed in previous phases of the project include a 1.6 mile 36-inch diameter pipeline loop in Newtown, CT placed in-service November 14, 2008 and two 10,300 horsepower compressor units at a new station in Milford, CT placed in service January 14, 2009.

"The successful completion of the 08/09 Expansion Project will improve system reliability and further diversify supply options for Iroquois' shippers by improving access to Atlantic LNG, north-eastern U.S. storage, and emerging Marcellus Shale production," according to Jay Holm, President of Iroquois Pipeline Operating Company.



## Iroquois Holds Open Season for NYMarc Project



On November 17, 2009, Iroquois announced an open season to solicit shipper interest in its NYMarc project proposed to connect rapidly expanding Marcellus gas supplies to New York, New England and Eastern Canadian gas markets. The estimated \$500 million project would include construction of 66 miles of 36-inch diameter natural gas pipeline in Southern New York and Northwest New Jersey as well as one compressor station in New York. The majority of the line is proposed to be located near existing energy corridors.

The open season will run from November 17, 2009 through January 29, 2010 and offers potential shippers the opportunity to request service as early as Fall 2014. Results from the open season will determine the design and scope of the project.

Iroquois' week-long campaign offers many fun activities starting with an ice cream social kickoff and concluding with a donor thank you finale lunch.


At this year's luncheon, the executive team was transformed into an 80's rock band and performed a spirited rendition of Bon Jovi's
